The Board currently has \$450,000 in Board funds available to reinvest (leaving approx. \$345,000 available for operating expenses).

I recommend that the Board reinvest \$450,000 in the following time periods:

- 1. \$100,000 in 2011
- 2. \$350,000 in 2014
