REGULAR MEETING

Mr. Boschult, Chair, called the meeting to order at 9:37 a.m.

The first item on the agenda was the approval of the minutes of the March 25, 2005, Regular Meeting and the April 21, 2005 Telephonic Meeting. Mr. Boschult asked if there were comments or corrections to the minutes. As there were none, Mr. Marshall moved to approve the minutes of the Regular Meeting dated March 25, 2005, and the minutes of the Telephonic Meeting dated April 21, 2005 as submitted. Mr. Boschult seconded; the motion carried unanimously.

EXECUTIVE DIRECTOR'S REPORT

Mr. Slosky reviewed the Board's fiscal status. As of the end of April, the Board had more cash on than normal due to fees from the U.S. Army Corps of Engineers, the City & County of Denver, and State of Colorado. He noted that the next investment, a Federal Agency Note of \$301,309, would mature on June 17, 2005. He referred the Board to the Investment Report, noting that several investments would mature in the fall.

He referred the Board to the Permit Fee Revenue table. This is a six-year comparison of permit fee revenue through May 31st of each year. The year 2005 shows the greatest revenue to date due to the fees from the Shattuck amendment, City & County of Denver, and the State of Colorado.

Following this was the Budget versus Expenditure Comparison through April 2005, 83.3% of the fiscal year. The budget does reflect the \$2,000 transferred from the contingency to Contract Services that the Board agreed to at the March 25, 2005 Board Meeting. Mr. Slosky reported that the Board was on or under budget through April 2005.

Mr. Slosky then referred the Board to the Export/Disposal table for 2005. To date, approximately 1,283 cubic feet had been authorized for export to the US Ecology-Washington facility out of the 12,555 cubic foot allowance.

CONSIDERATION OF APPLICATION FOR DESIGNATION OF THE CLEAN HARBORS FACILITY IN COLORADO AS A LIMITED REGIONAL DISPOSAL FACILITY
